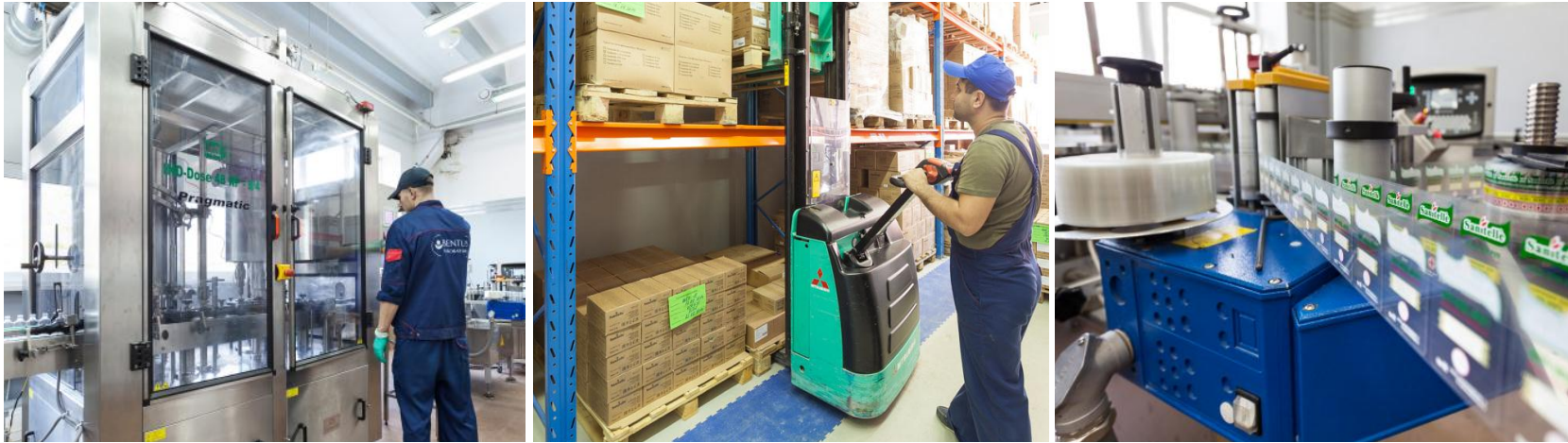

- Due to the nature of business involving ethyl alcohol, Bentus Laboratories is fully compliant with all local and federal licensing requirements as well as environmental controls and conditions.
- An on-site laboratory ensures meticulous control of the quality of both raw materials and finished products. The laboratory is accredited in accordance with the requirements of International standard ISO/IEC 17025:2005 (GOST ISO/IEC 17025-2009) for technical competence.

# MANUFACTURING FACILITY



The production capacity of Bentus Laboratories is **17,000** liters of finished products per day, which is **6.2** million liters per year.

**60%** of the current production is in gel form, the remaining **40%** are liquid-form products.



# MANUFACTURING FACILITY



## Substance manufacturing equipment:

1. 60 dL and 25 dL capacity reactor-mixers;
2. 80 dL automatic mixer.

## Bottling and packaging equipment:

1. Automatic line for filling and capping;
2. Semi-automatic dispensers / filling machines;
3. Automatic labeling machines and applicators.
